Rock Island - Western Illinois Area Agency on Aging (WIAAA) Public Information Document (PID) provides a summary of our FY2022 Area Plan. Each year we submit an Area Plan to the Illinois Department on Aging requesting federal and state funding to provide home and community based services for older adults, and their caregivers and in some instances adults with disabilities living in Bureau, Henderson, Henry, Knox, LaSalle, McDonough, Mercer, Putnam, Rock Island, and Warren counties in Illinois. We will also be submitting a request for funding for the Regional Ombudsman Program to serve Adams, Brown, Calhoun, Hancock, Pike and Schuyler counties in West Central Illinois. The Area Plan is developed by assessing the needs of older adults, their caregivers, and adults with disabilities through our Aging and Disability Network to identify issues for short and long range planning and setting priorities for funding.
